Sub: Resignation as Statutory Auditors of the Company

Dear Sirs.

We have been reappointed as Statutory Auditors of the Company in its Annual General Meeting held on September 30, 2019 for a period of 4 years. We have already completed the statutory audit for the FY 2019 – 2020 and have issued our report on the financial statements for the said financial year.

Please refer to the discussions we had with you regarding the audit fees. Please note that there is substantial time involved in conducting audit of the Company considering the operations and infrastructure. Further, the company has indicated that there is a proposal to merge Gufic Lifesciences Private Limited with the Company, resulting in additional manufacturing facility. It has been further indicated that there will be enhancement of the production capacity and introduction of newer products. The said factors will further increase the time involvement in conducting the audit of the company. We had indicated to the Management that our audit fee is not commensurate with the time and efforts involved; hence requested to increase our audit fees, which has not been accepted favourably by the Management. In these circumstances, we are unable to continue to act as the Statutory Auditors of the Company and we hereby tender our resignation as Statutory Auditors of the Company.

In terms of SEBI circular ref CIR/CMD114/2019 dated October 18, 2019, it is hereby clarified that we will complete the limited review of the financial results for the quarter ended June 30, 2020 and issue our report as per clause 33 of SEBI LODR Regulations 2015 read with SEBI circular SEBI/HO/CFD/CMD1/CIR/P/2020/140 dated 2020 granting extension of time for

submission of unaudited financial results for quarter ended June 30, 2020. Our resignation may be treated as effective from the date on which the financial results for the quarter ended June 30, 2020 are approved by the Board of Directors.

The information to be obtained by the company from the Auditor's for the resignation as required by SEBI circular CIR/CFD/CMD1/114/2019 dated October 18, 2019 in Annexure A, is attached herewith.
